1. Redevelopment Sites - As part of the RRC Program we continue to gather information on various buildings. Several buildings in the downtown were discussed as potential redevelopment sites. Among those were the Masonic Temple, 1st National Bank Bldg, Delft Theater Bldg, Old 8th Street Coffee House Bldg, Office Service Bldg, Old Richter Office Bldg, and Peterson Hotel Bldg. The House of Ludington Excel Reality Project was also discussed. These sites once officially identified must be listed on the City's web site.

NEW BUSINESS

1. Discussion House Bill 5232:

HB 5232 was introduced on January 26, 2016 by Rep Chris Afendoulis (Grand Rapids) and Sen. Peter MacGregor, (Rockford). This Bill has serious detrimental impacts to historic resources and local historic districts through proposed amendments to Michigan's Local Historic District Act, PA 169 of 1970. Discussion took place and it was decided to correspond with our local legislators to voice our opinion against the bill.
