Library Programs / Services

A display of photographs and memorabilia from the Honor Flight was featured in the library display case for November, in honor of local Veterans. A video of recent Honor Flight missions was also featured for the month. The Children's department will be featured in the City's Christmas Parade on December 1st. The Delta County Historical Society winter outreach series has been scheduled for February 21, March 21 and April 25. The library will partner with the Superiorland Library Cooperative to present a hands-on workshop for Tech Tech Week in March. The library will participate in the Great Michigan Read in April. The featured title is *X: A Novel*, by Ilyasah Shabazz. Dr. Alan Scott Willis, history professor at NMU, will be the scholar for the event and will present a talk on April 12th at 6pm. Response to the drop-in technology training sessions (Tech Tuesdays) has been positive. Sessions are scheduled into January. A "Family Fun Night" with the Delta County ISD is scheduled for this Wednesday, Nov 28th at 6:30 p.m. Children's events for December include Lego Club on Dec 9th, a family holiday sing-along on Dec. 14th, and Storytime with Santa on Dec 16th at 1:30

- A) <u>December Schedule</u> The library director will be on medical leave from December 7 through December 26th. - B) Net Neutrality The Chair presented information on the Federal governments potential repeal of "Net Neutrality" laws that regulate Internet service providers, inasmuch as it impacts the ability of public libraries to provide open and equal access to information. J. Hallett made a motion opposing changes to the rules on net neutrality and authorizing the library director to email representatives with a request not to repeal. T. Wiles seconded, unanimous.

May 17th (Thur)-

Public Hearing and adoption of City budgets. First reading of the Appropriations Ordinance, including the millage rate, and first reading of the Tax Levy Ordinance, with second reading and adoption set for the May 24th special meeting. First reading of Utility Ordinances, with second reading and adoption set for the Monday, June 4th special meeting.

May 24th (Thur)-

(Special Council Meeting) Second reading and adoption of the Tax Levy Ordinance and the Appropriations Ordinance.

June 4th (Mon)-

(Special Council Meeting) Second reading and adoption of the Utility Ordinances.
