January 22, 2018

A meeting of the Escanaba Public Library Board of Trustees was held January 22, 2018 at 5:00 p.m. in Room C102 of the Escanaba City Hall/Library Complex, Escanaba, MI 49829.

APPROVAL/CORRECTIONS(S) TO MINUTES: The minutes of November 27, 2017 were accepted on

consensus.

APPROVAL/ADJUSTMENTS TO THE AGENDA: The agenda was accepted on consensus.

DIRECTOR'S REPORT:

Use Measures: Library director will continue to look for more meaningful ways to provide library statistics and use measures. Graphing data over time and utilizing reports from "Blue Cloud Analytics" will be featured in future meetings.

Financials: Reviewed.

Administration: Library director is serving as Secretary for the reconstituted advisory board to the Superiorland Library Cooperative. Library director is serving on the planning committee for the annual meeting of the Upper Peninsula Region of Library Cooperation. Library director applied and received funding for children's materials from the Dorothy Louise Kyler Foundation (Ohio). The grant was \$3,000 and must be spent by the end of March. Original oak tables from the Carnegie building are being refinished, courtesy of a donor. The library is participating in a committee sponsored by the Visitor and Convention Bureau that is promoting the summer activities around Ludington Park for 2018.

Library Programs / Services

The library's Lego Club, run by volunteer Aaron Deiter, has received a \$500 grant from the Escanaba Rotary. Two altered book art classes (Feb 22 and March 22nd) have been added to the calendar of public programs. The library is working with the Michigan Humanities Council on hosting Kekla Magoon, author of *X: a Novel*, which is the 2017 selected titles for the Great Michigan Read. The event is anticipated for May 16th.

Friends of the Library: Recent Contributions to the library include funds for the digital subscriptions, Ancestry Library (\$2,100) and Mango Languages. (\$2,272), as well as the print Sunday edition New York Times (\$439). The Publicity Committee meets on January 29th.

UNFINISHED BUSINESS:

A: Net Neutrality: Director provided an update on the current status of Net Neutrality legislation and action, as pertains to public libraries.

NEW BUSINESS:

A: Library Budget, Fiscal Year 2018-19.

Library director provided calendar of meetings for budget process for Fiscal Year 2018-2019. General discussion on budgetary conditions affecting the library. Review of revenue sources and general categories in expenditures. Discussion of fund balance use. Trustees are encouraged to participate in the public comment during budget hearings. Library director will keep Board apprised of important dates and times and provide talking points when appropriate.

POLICY STATEMENT CITY OF ESCANABA LIBRARY BEZOLD BEQUEST

The following is the policy of the City of Escanaba in regard to the Bezold Bequest.

In 2004, the City was named as a beneficiary as part of the Bezold bequest to utilize funds designated for the City of Escanaba Public Library. The bequest shall include the expenditure of funds for the following purposes: Children's reading materials, computer software and any learning aid which directly provides learning for children and youth utilizing the resources of the City of Escanaba Public Library. Expenditure levels shall be established through the City's annual budgetary process. A separate accounting number and system shall be assigned through the City Controller's Office in order to track any expenditures. At the direction of the City Controller, all proceeds from the Bezold Bequest shall be placed in a trust fund which accrues interest revenue. At no maintenance, furniture, or any other apparatus used for the Escanaba Public Library. Any expenditure shall be done with a review of the Public Library Director with affirmation by the City Manager and the City Controller subject to the approval during the budget process of City Council.

NB-3 Moyle moved, Berthiaume seconded to approve the annual agreement with the Delta County Historical Society, as defined, for \$5,000.

Approval of Escanaba Exchange Club to reserve Ludington Park for activities on Sunday, July 4, 2004.

Council was requested to approve the Exchange Club's request to reserve a portion of Ludington Park for the annual "Day in the Park" activities scheduled for July 4, 2004. The Club's Independence Day celebration includes children's games, pony rides, food, novelty vendors and music. As a condition of approval, the Club was to provide liability insurance and confirm all health certificates for food vendors.

Moyle moved, Evans seconded CARRIED UNAMIOUSLY approve the Escanaba Exchange Club's reservation of Ludington Park for July 4, 2004.

Approval of a transfer of funds to the Escanaba Friends of the Library.

The Escanaba Public Library was the beneficiary of a large bequest from the Margaret Bezold estate for \$265,624.98. Miss Bezold was a kindergarten teacher with the Escanaba schools for 44 years. Miss Bezold's requirement was that the funds be used for reading materials, as opposed to bricks, mortar, roofing or maintenance, with a strong preference it be used primarily for children's materials.

It was suggested that Miss Bezold's bequest be transferred to the Friends of the Library. The Friends of the Library were good stewards of memorials and bequests, and provided many extras the budget of the Library does not provide. The Friends of the Library could work with Library staff to ensure the proper use of these funds.

City Attorney Peterson suggested Council acknowledge the acceptance of Miss Bezold's bequest, and further recommended the bequest remain under control of the City. Mr. Peterson advised Administration should develop a policy on how the funds would be used, along with how the expenditures would be made with direction from the Friends of the Library. City Manager Terry echoed Attorney Peterson's recommendation.

Council Members and Library Director Cary discussed the following:

- The requirements of the Miss Margaret Bezold bequest;
- Directed Administration to develop a policy regarding the requirements that the funds be used for reading materials, as opposed to bricks, mortar, roofing or maintenance, with a strong preference it be used primarily for children's materials,

as defined by Margaret Bezold;

- Director Cary advised there was not any specification as to retaining the principal, but yearly expenditures were not to affect the library budget;
- It was Council's strong preference that the policy be written to only use the interest each year in order to keep forever the name of Margaret Bezold at the Escanaba Public Library:
- Council also suggested the policy be written so the recommendation of yearly expenditures would come from the Friends of the Library.
- Berthiaume moved, Evans seconded to graciously accept the bequest from the Margaret Bezold estate for \$265,624.98.

Approval of proposals to perform the Deep Water Port Feasibility Study. Expenditures were budgeted in the current 2004/05 Fiscal Year Budget.

City Manager Terry provided a brief explanation for each of the four contracts to perform a Deep Water Port Feasibility Study.

Moyle moved, Heikkila seconded to approve four contracts to perform specific tasks associated with the feasibility study for the development of a 100-acre marine terminal in the City of Escanaba as follows:

- Astra Designs, International, Inc. (ADI) \$240,000 for a econometric study;
- DLZ \$74,395 for project planning and coordination, existing conditions review, and report preparation;
- Foster, Swift, Collins & Smith, P.C. hourly fee structure as outlined in their brochure and will serve as the City legal counsel;
- Advocacy Specialists, L. L. C. \$4,000 per month for public relations.
