# JOINT GOVERNMENTAL ROUND TABLE DISCUSSION Wednesday, February 10, 2016

#### **NEW BUSINESS**

# <u>Presentation – Delta County Administrator Ryan Bergman and Sheriff Ed Oswald – Delta County Jail Project.</u>

Mr. Ryan Bergman and Sheriff Ed Oswald updated those in attendance the proposed jail project and proposed May 3<sup>rd</sup> millage currently under consideration. (See Attachment – A)

- The proposed new Jail was a \$19.9 million Bond Proposal;
- Provided a brief history of the current jail and consultant activities for the proposed new jail;
- Proposed new jail site was the current County Service Center;
- Project would accommodate approximately 180 inmates, and reviewed proposed Pod design;
- Reviewed proposed financial details for the project that would cost on average approximately \$45 on a \$100,000 home;
- Reviewed project timeline based on an approval at the May 3, 2016, special election;
- To help pay for operating cost, County would sell extra beds to neighboring communities;
- Need to pay for a jail eventually. Current facility was outdated and if fell in a state of disrepair, and failed, would drain financial resources within a year;
- Rural Development Funding would come in at a reduced interest rate that would save approximately one million dollars;
- Millage rate would fluctuate to pay the debt.

### **Update – Delta Chamber of Commerce – Community Events Calendar.**

Rick Elrod of the Delta Chamber of Commerce advised they were in the process of updating their 2016 Community Events Calendar for all events taking place in Delta County. Their goal was to provide an opportunity for community organizations to promote their upcoming event and to ensure their events appear on the Community Events Calendar. Mr. Elrod stated, any business or group, were encouraged to put their event on the Community Event Calendar to promote their event;

#### <u>Update – Delta County Airport – Commercial Airline Services.</u>

Mrs. Kelly Smith, Delta County Airport Manager, provided an update on the new schedule for commercial airlines services at the Delta County Airport. The proposed new Airline schedules would be changing on March 2, 2016. Mrs. Smith advised it was important to keep flights at 10,000 seats to ensure funding from the Federal Government.
