City Hall Facilities and Services

City Hall, 410 Ludington Street, (906) 786-9402

City Hall houses the City of Escanaba offices (which is also the office for Escanaba Municipal Utilities) and is your link to the municipality. Staff will answer your questions or direct you to the appropriate individual.

Municipal Sewer and Water

The municipal sewer and water infrastructure is in place in the City of Escanaba to ensure clean, safe water to approximately 5400 users. For service or other questions, please

contact the Utility Office at (906) 786-0552. This service is billed monthly with your electric service by Municipal Utilities.

Municipal Electric

The municipal electric service is available for all City of Escanaba residents and certain outlying areas. This service is billed monthly with your sewer and water services by the Escanaba Municipal Utilities.

Garbage and Recycling Services

Garbage and recyclables are picked up curbside. There may be some changes in the schedule due to holidays. For more information contact the Department of Public Works at (906) 786-1842.

Public Safety

The City of Escanaba maintains an active and dedicated Public Safety Department for your protection. Currently, officers are available to respond to fire, vehicular and other emergencies. The department maintains a pumper, tanker and rescue van, all equipped with the necessary support apparatus. In an emergency, residents should call 911. Public Library

The Library, located at 400 Ludington Street, is an educational and recreational hub of the community, offering a wide selection of books, magazines, newspapers, DVDs and audio books, as well as public Internet and free wireless. Voter Registration Information

Before you can exercise your right to vote in any election, you must become a registered voter. Voter registration is an easy process described below. The City Clerk's Office encourages everyone to exercise their right to vote! Participate in our electoral process --- register and attend the polls on Election Day! To register to vote you must be a United

States citizen at least 18 years of age by Election Day, a resident of Michigan and the City or Township where you are applying to register to vote.

Where do I register to vote? City Clerk's Office, County Clerk's Office, Secretary of State Offices, Department of State Offices, Family Independence Agency, any agency providing public assistance or services for persons with disabilities.

Register by mail - Persons registering to vote by mail are required to vote in person the first time they vote, unless they are members of the military, overseas, handicapped, or a senior citizen.

To be eligible to vote, you must register at least 30 days prior to any election in Michigan. This gives your local clerk time to process the voter registration forms and to send your Voter Identification Card.

Whenever you move to a new City or Township, you must re-register to vote. If you move within a City or Township, you must update your address. This can be accomplished through your local City Clerk, at your polling place on Election Day, at a Secretary of State Branch office, or by mail.

Escanaba Wading Pool

The Escanaba Wading Pool is open from mid June to mid August. This outside facility has a wading pool depth of 9". For further information contact the Recreation Department at (906) 786-4141.

Youth and Adult Activities

The City summer sports program offers soccer, swimming lessons and tennis. Programs are organized by the Escanaba Recreation Department. The Escanaba Little League offers softball, baseball and t-ball. The Civic Center facility located at 225 North 21st Street is open for youth activities from mid September to the end of April. For additional information on adult activities, contact the Civic Center at (906) 786-4141.

Parks and Trails

You will find parks and trails for your recreation pleasure within the community area of Escanaba.

Ludington Park is a 120-acre municipal park offering a children's playground, band shelter, picnic tables, and public beach. Four tennis courts, soccer field, six beach-sand volleyball courts and one basketball court. The Ludington Park Beach will be open from mid June to mid August. There is also a 165 slip marina and historical museum.

Pavilion – The Ludington Park Pavilion is located near the south end of the park. There is a 110-volt electric service, potable water for cooking/cleaning and a large capacity barbecue grill. The facility is capable of accommodating 10 eight-person picnic tables with ample green space in the surrounding area to facilitate additional tables/persons. Clean, modern restroom facilities are located

conveniently close to the Pavilion. Parking accommodations are also close by at the tennis court lot, Jenkin's Drive or the Bandshell parking lot. Advance reservations are required for family socials, picnics and outings. There is a \$50.00 reservation fee per day/event. Please contact the Recreation Department at (906) 786-4141.

Ludington Park Gazebo – The Gazebo is located across from the Sand Point Lighthouse near the east end of Ludington Park. The 20' x 20' Gazebo is equipped with both internal and external electrical outlets and external lighting for subtle nighttime illumination. Many people have found the Ludington Park Gazebo an excellent location for wedding ceremonies, wedding pictures and family reunion pictures. This facility provides beautiful views of the Ludington Park Fountain and the Harbor. On-street parking is available. Restrooms are nearby at the Municipal Marina. Advance reservations are required for wedding ceremonies, family/group pictures, etc. There is a reservation fee of \$30.00 per two-hour block. For reservations contact the Recreation Department at (906) 786-4141.

Ludington Park Bandshell – The Bandshell is a multi-use facility capable of accommodating plays, concerts, religious functions and other ceremonies and social events. Located on the south end of Ludington Park, the facility is capable of seating 300 people with a large expanse of green area and hills to accommodate hundreds of other spectators. Support facilities for the Bandshell include parking for approximately 100 vehicles and restroom facilities immediately north of the Bandshell area. Advance reservations are required for the use of the Ludington Park Bandshell. There is a \$50.00 reservation fee per day. The Escanaba City Band performs every Wednesday at 7:30 p.m. from mid June to mid August. For reservations contact the Recreation Department at (906) 786-4141.

Harbor Hideout Playground – Located in Ludington Park, Harbor Hideout is Escanaba's own 22,500 square foot children's adventure facility. The structure was designed by local community volunteers and area school children and built with volunteer labor. This facility is suitable for children of all ages. Consider this playground a "must see" for all residents and visitors alike. Playground is barrier-free and nearly all features are handicapped accessible. Slides, transfer points, swings and playground cover are suitable for the mobility impaired.

Royce Park – Located on South 19th Street and 7th Avenue South. Two tennis courts and one basketball court. Outside ice rink available from January to February weather permitting with a warming shack. There is also a playground and ball diamond on site.

Besse Park – Located on 8th Avenue South and South 30th Street. The pavilion is a sheltered structure and is capable of accommodating nine (9) eight-person picnic tables, including handicapped accessibility. There is a volleyball court, disc golf course, tether ball and children's playground.

Veteran's Park – Located on Lake Shore Drive and 13th Avenue South. Two tennis courts and one basketball court. There is also a playground and ball diamond on site.

Webster Park – Located on the North 1300 block and North 19th Street. Outside ice rink available from January to February weather permitting with a warming shack.

Escanaba High School – Located on 5th Avenue South and South Lincoln Road. Four tennis courts. There is a walking/running track available on site.

Stephenson Park – Located on North 19th Street and 15th Avenue North. One basketball court. There is also a playground and ball diamond on site.

Rose Park – Located on Washington Avenue and Stephenson Avenue. One tennis court and playground area available.

Ogden Avenue Park – Located on Ogden Avenue and 4th Avenue South. Outside ice rink available from January to February weather permitting.

Escanaba Marina and Boat Launches

The Escanaba Marina, Ludington Park Boat Launch and the North Shore Boat Launch are open from May to October. The fish cleaning station located at the North Shore Boat Launch will be available from May to October.

Cemeteries

There are two cemeteries within City of Escanaba limits. Holy Cross Cemetery is located on M-35. Lakeview Cemetery is located at 2110 3rd Avenue South.

Zoning

In the City of Escanaba, zoning laws regulate the use of all land and buildings in the municipality. We have a downtown development district that is governed by ordinances, as well. For detailed zoning information contact the Community Preservation Department located at City Hall or phone (906) 786-9402.

Building Permits

Building permits are required for all new construction, and for additions, garages, accessory structures and decks, etc. Zoning approval is required by the City of Escanaba prior to obtaining a building permit. For further information contact the Community Preservation Department for a zoning application at (906) 786-9402. Building permits for the City of Escanaba are handled by the County Zoning Administrator, Dan Menacher at (906) 789-5189, 310 Ludington Street, Escanaba, MI 49829.

Burning Permit

A Burn Permit is required for burning brush, leaves, etc. and can be issued at Escanaba Public Safety Department. Special Precautions: clear 20 feet around each pile to be burned, burn one pile at a time, adding to the burn pile shall be permitted only with advanced approval, the fire shall be extinguished immediately upon direction of the Chief of Public Safety, burning shall commence no earlier than 7:00 a.m. and shall be

completed no later than 6:00 p.m., a permit (pre- and post-burn) inspection shall be completed for each pile to be burned, and a Fire Watch is required.

Fire Watch – is defined as a responsible person on site with equipment capable of either putting the fire out or contacting the Public Safety Department should the fire burn out of control. A bulldozer and operator shall be on site from the time of burn through one hour after the burn.

Stipulations – Any person who sets a fire without taking reasonable precautions to prevent the escape thereof or leaves the fire before it is extinguished is guilty of a misdemeanor. Any person who maliciously sets a fire which endangers human life or destroys the property of another, may upon conviction, be assessed a fine of not more than \$10,000 or imprisonment for a term of not over ten years or both such fine and imprisonment. Any person who negligently allows a fire to escape is liable for all expenses incurred by the State of Michigan and/or the City of Escanaba in the suppression of such fire. Any permit issued may be revoked if conditions are such that burning may not be done safely. This permit does not supersede any other Act or Ordinance which further restricts or prohibits the setting of fires.

Dog and Cat Licenses

Dog and cat licenses are required. Proof of a current rabies vaccination must be presented in order to acquire a license. Prices vary. For more information contact the Delta County Treasurer's Office, 310 Ludington Street at (906) 789-5117.


